The duration of the post will be 6(Six) months. The engagement will be purely temporary with the tenure of which will initially span for 06 (six) month with a monthly stipend of Rs.55,000.00 (Rupee fifty-five thousand) only.

Role of Aspirational Blocks Fellow:

The Aspirational Blocks Fellow will be positioned as a critical link between the Block Level Officials (BLOs) of Bhergaon Development Block and NITI Aayog. The fellow's primary responsibilities will include:

1. Collaborating with Block Level Officials to design and execute development strategies aligned with ABP thematic areas.
2. Conducting regular field visits to assess project implementation, address challenges, and collect ground-level insights.
3. Analyzing data and providing evidence-based recommendations to BLOs, District level Officials to optimize developmental initiatives.
4. Organizing workshops, awareness campaigns, and skill-building programs to empower the local community.
5. Keeping States and NITI Aayog abreast with the issues, challenges and need for support.
