Terms of Reference:-

---

1. Any person with a post Graduate Degree in Social Work or Sociology or Psychology or Child Development or a graduate with minimum three years of experience in child education and development or protection issues is eligible for Support Person.
2. Provided that in accordance with Rule 5 (6) of the POCSO Rules 2020, an entity qualified to act as a Support Person may also include an organization actively engaged in the realm of child rights or child protection. Additionally, an official associated with a children's home responsible for the custody of the child may also be eligible to apply as a Support Person.
3. The selected Support Persons shall be engaged for a period of three years which shall be yearly reviewed by the DCPO and shall be extended beyond 3 years on the basis of the recommendation after review conducted by the DCPO. The said recommendation must be approved by the District Magistrate.
4. Any support person engaged for the purpose of assisting a child under this Act, shall be paid on a pro-rata basis, determined by the number of days worked.
5. The support person shall be provided reimbursement as per actual expenditure for the travel undertaken with the minor victim and on production of bills duly verified by CWC.
