ORDER

In pursuance of the empanelment notice vide No. DM-16/204/2025-DDM-UDL/8-9 (E.164295) dated 01-12-2025, a total of 06 (six) contractors, namely: 1) Ramcharan Boro, 2) Prachurjya Das, 3) Fwilao Basumatary, 4) Somla Daimary, 5) Babul Chouhan and 6) Dipen Das have submitted documents for empanelment to undertake repairing, renovation and reconstruction works of the 2022 flood-affected Schools and Anganwadi Centres (AWCs) under Udalguri District.

Whereas, after careful scrutiny of the submitted documents, it has been found that 02 (two) contractors, namely 1) Ramcharan Boro, and 2) Babul Chouhan have not submitted the Trade License as per the prescribed criteria. (Checklist enclosed)
