The Photo Electoral Rolls are to be prepared as per procedure prescribed in the Rule 11 of the Bodoland Territorial Council (Election) Rules, 2004 based on the corresponding Assembly Electoral Roll in force with date of eligibility as 01.01.2025.

The Returning Officer shall also publish the list of polling stations of the constituencies in accordance with the provision of Rule 12 (1) of the Bodoland Territorial Council (Election) Rules, 2004.

The list of Election Officers, Returning Officers and Assistant Returning Officers against respective districts / sub-divisions / constituencies of the Bodoland Territorial Council has already been notified vide Notification No.SEC.07/2025/55 dated 18.03.2025 and they shall act as per the said Notification.
