**PROHIBITORY ORDER**  
**U/S 163 BNSS**

**WHEREAS**, it has been observed that due to plying of heavy vehicles like *dumpers/trucks/tractors* etc in the high traffic areas of the district in the rush hours, a number of road accidents have been reported in the last few weeks.

**WHEREAS**, reckless driving of heavy vehicles in high traffic areas of the district, especially during the rush hours of morning and evening have endangered the life of the public in general along with the school/office/college going citizens of the district.

**WHEREAS**, information have been received from various ends regarding sporadic movements of vehicles in wrong-side of legal traffic flow direction on various roads in the district including township areas with high traffic, which pose a threat of road accidents and danger to human life.

**AND WHEREAS**, in the interest of public safety, the undersigned is of the opinion that, immediate and stringent action is required to be taken to prevent such road accidents and to avert danger to human life in road accidents.

**NOW, THEREFORE**, in view of the above, I, Shri Pulak Patgiri, ACS, District Magistrate, Udalguri, in exercise of the powers conferred upon me under **Section 163** of the BNSS, do hereby promulgate the following orders with immediate effect:

1. Plying/movement of heavy vehicles like dumpers, tractors and trucks and other heavy vehicles as defined under MV Act, 1988 is hereby prohibited between 7:00 AM to 9:30 AM & between 1:00 PM to 4:30 PM throughout the Udalguri district.
2. Plying/movement of all types of vehicles in the wrong direction of traffic flow is hereby prohibited throughout the Udalguri district.
3. Speed limits of all types of vehicles are hereby restricted to 30 Km/hr within the Udalguri Municipal Board area and Tangla Municipal Board area at all times.
4. In other towns and peripheral areas near townships like Mazbat town, Kalaigaon town and road intersections at Rowta, Orang and Dimakuchi the speed limits of all types of vehicles are hereby restricted to 30 Km/hr at all times.

As circumstances do not admit of serving of a notice upon any individual(s) or organization(s), as provided u/s 153 BNSS, this order is being passed ex-parte as envisaged u/s 163 (2) BNSS and it shall come into force with immediate effect and remain in force until further order. Anyone aggrieved by this order may approach the competent authority for modification/waiver of the order.

The Sr. Superintendent of Police, Udalguri & D.T.O., Udalguri shall ensure strict enforcement of this order in letter and spirit.

**Any violation of this order is punishable u/s 223 of BNS.**
