ORDER

Whereas it has been brought to the notice of the undersigned that during the picnic season, an influx of vehicles in and around the picnic spots within the jurisdiction of Udalguri district is causing increased traffic congestion, reckless driving and road safety hazards.

And whereas some drivers and riders and pillion riders under the influence of alcohol or any intoxicating substance are causing accidents while returning back from the picnic spot.

And whereas it is necessary to regulate vehicular movement and impose restrictions to prevent such accidents and to ensure public safety across the district.

And whereas most of the picnic spots in the districts lie within elephant corridors and movement of elephant in such areas leads to human-animal conflict, resulting in the loss of life.

And whereas during the winter season the picnic spots/areas are covered by fogs and riding/driving in foggy conditions requires extra caution and reduced visibility makes it difficult to see other vehicles or obstacles on the road.

Now, therefore, in the exercise of powers conferred upon me under provision of section U/S 163 of BNSS Act, I, Sri Pulak Patgiri, ACS, District Magistrate, Udalguri do hereby impose the following prohibitory orders with immediate effect.

1. All picnic parties must vacate the picnic spots by 4:00 P.M.
2. The use of plastic, high-decibel sound systems or any other instruments producing high-decibel sounds at picnic spots is strictly prohibited.
3. No vehicle shall exceed the speed limit of 20 km/hr within 1 km of designated picnic areas.
4. No vehicle shall carry passengers beyond its permitted seating capacity.
5. Drivers and riders under the influence of alcohol or any intoxicating substance are strictly prohibited from operating vehicles.
6. Rash driving such as racing or performing stunts is strictly prohibited in picnic areas and their approach roads.

Considering the seriousness and exigency of the situation, this order is passed ex parte.

Any violation of this order shall invite prosecution as per relevant provision of law.
