1. Pursuant to the New HR methodology for induction of Agniveervayu under 'Agnipath Scheme', aimed to provide an opportunity to Nation's youth to experience military way of life for a period of four years, Indian Air Force invites ONLINE applications from unmarried Indian male and female candidates for selection test on 30 March 2026/ 31 March 2026 to join the IAF as an AGNIVEERVAYU. The number and employability of female candidates will be decided as per service requirement.

(THE SELECTION TEST IS NOT FOR SELECTION AS COMMISSIONED OFFICERS/ PILOTS/ NAVIGATORS/ AIRMEN)

2. Application is required to be filed only ONLINE by the candidates and detailed instructions to fill up the same are available at <https://ibscruitment.ecdfc.in>

3. The examination is valid for AGNIVEERVAYU INTAKE 01/2027.

4. ONLINE REGISTRATION shall commence at 1100 Hr on 12 January 2026 and will close at 2300 Hr on 01 February 2026. Only ONLINE REGISTERED applications shall be accepted. For registration log on to <https://ibscruitment.ecdfc.in>.

Note:- Candidates are advised to register at the earliest opportunity as no extension of registration dates will be accommodated.

ELIGIBILITY CRITERIA

5. Age

5.1. **Date of Birth Block:** Candidates born between 01 January 2006 and 01 July 2009 (both dates inclusive) are eligible to apply.

5.2. In case, a candidate clears all the stages of the Selection Procedure, then the upper age limit as on date of enrolment should be 21 years.

6. **Marital Status and Pregnancy.** Only unmarried candidates (male & female) will be eligible for enrolment as Agniveervayu and they shall undertake not to marry during the defined engagement period of four years. Keeping in view limited period of engagement of Agniveervayu inclusive of training, skill development, activities, practical as well as formative assessment and organisational requirement of continued service of Agniveervayu during the engagement period, longer absence of Agniveervayu during the engagement period will adversely affect the operational efficiency of the Indian Air Force. Regular cadre as Airmen. Female candidates additionally shall be required to undertake not to get pregnant during the engagement period of four years. Such female Agniveervayu on becoming Low Medical Category (LMC) due to pregnancy shall be liable to be discharged from service. Pregnancy will defer the female Agniveervayu for selection into Regular Cadre. At the time of enrolment, candidates shall require to sign a voluntary undertaking accepting above conditions.

7. Educational Qualification.

7.1. **Science Subjects.** Candidates should have passed Intermediate/ 10+2/ Equivalent examination with Mathematics, Physics and English from Education Boards recognised by Central, State and UT with minimum 50% marks in aggregate and 50% marks in English.

OR

Passed Three years Diploma Course in Engineering (Mechanical/ Electrical/ Electronics/ Automobile/ Computer Science/ Instrumentation/ Technology/ Information Technology) from Central, State and UT recognised Polytechnic Institute with 50% marks in aggregate and 50% marks in English in Diploma Course (or in Intermediate/ Matriculation, if English is not a subject in Diploma Course).

OR

Passed Two years Vocational Course with non-vocational subject viz. Physics and Mathematics from Education Boards recognised by Central, State and UT with 50% marks in aggregate and 50% marks in English in Vocational Course (or in Intermediate/ Matriculation, if English is not a subject in Vocational Course).

7.2. **Other than Science Subjects.** Passed Intermediate/ 10+2/ Equivalent Examination in any stream/ subjects from Education Boards recognised by Central, State and UT with minimum 50% marks in aggregate and 50% marks in English.

OR

Passed two years Vocational Course from Education Boards recognised by Central, State and UT with minimum 50% marks in aggregate and 50% marks in English in Vocational Course (or in Intermediate/ Matriculation if English is not a subject in Vocational Course).

Note - 1:- Candidates eligible for Science Subjects examination (Including Intermediate/ 10+2/ three years diploma course in engineering or two years vocational course with non-vocational subjects of Physics and Maths) are also eligible for Other than Science Subjects and would be given an option of appearing in both Science Subjects and Other than Science Subjects examination in one sitting while filling up the online registration form.

Note - 2:- Education Boards recognised by Central, State and UT as on date of registration shall only be considered.

Note - 3:- Exact aggregate percentage of marks before decimal as written in the marks sheet of 10+2/ Intermediate/ Equivalent Examination/ Three years Diploma Course/ Two years Vocational Course OR calculated as per the rules of concerned Education Board/ Polytechnic Institute shall only be considered (For example 49.99% should be taken as 49% and not to be rounded off to 50%).

8. **Domicile Category.** Candidates have to choose one of the domicile categories mentioned below and declare the same as their domicile State/ UT in the domicile column in the online application form at the time of online registration. The following are the categories of domicile.

8.1. **Permanent Domicile.** Permanent Domicile of the districts of State (s)/ UTs. The candidate shall produce 'Domicile Certificate' issued by any Gazetted Officer in Revenue Department or any other official authorised by the State Government of the particular State/ UT.

8.2. **COAFP-I.** Children of serving Air Force personnel (Officers/ Airmen/ NCOs) and Unit Cadre Civilians paid from Defence Estimates) produce latest COAFP (Children of Air Force Personnel) Certificate.

8.3. **COAFP-II.** Children of Air Force personnel (Officers/ Airmen/ NCOs) and Unit Cadre Civilians paid from Defence Estimates) whose father/mother is Retired/ Discharged/ Deceased and they are residing in the districts of State (s)/ UTs. Such candidates will produce a proof of minimum stay of one year along with original and photocopy of Service Book/ Discharge Book/ Casualty Service Certificate/ Service Particular Certificate (issued from DPO-3/ DAV as applicable) in case of Officers/ Airmen/ NCOs (E) and a Certificate duly signed by OIC Civil Admin and counter signed by CO/C Adm O of the last served unit, in case of Civilians.

Note:- Domicile Category once chosen will not be changed later as the same will be applicable to the candidate at the time of shortlisting for Phase-II exam and preparation of Provisional Select List (PSL) which will be done state-wise as per the vacancies allocated for each state/ UT. As per the category chosen during registration, candidate will be required to produce relevant original Domicile Certificate/ COAFP Certificate (if shortlisted for Phase-II Exam) for every stage of selection till enrolment.

9. **Mandatory Medical Standards.** General Medical Standards for AGNIVEERVAYU male & female candidates are as follows:-

9.1. Height.

9.1.1. **For Male Candidates.** Minimum acceptable height is 162 cms

9.1.2. **For Female Candidates.** Minimum acceptable height is 152 cms. For candidates belonging to North East or hilly regions of Uttarakhand, a lower minimum height of 147 cms will be accepted. In case of candidates from Lakshadweep, the minimum height will be 150 cms.

Note:- Female candidates availing height relaxation for being domicile of North East/ hilly regions of Uttarakhand/ Lakshadweep are to submit domicile certificate with endorsement of domicile status at the time of Phase-II testing. Further, female candidates from hilly regions of Uttarakhand must have specific endorsement of hilly region in their domicile certificate.

9.2. **Weight.** Weight should be proportionate to height and age as applicable for IAF

9.3. Chest.

9.3.1. **For Male Candidates.** The chest wall should be well proportioned and well developed. Minimum chest circumference should be 77 cms and the chest expansion should be atleast 05 cms

9.3.2. **For Female Candidates.** The chest wall should be well proportioned and should be with minimum range of expansion of 05 cms

9.4. Hearing.

Candidate should have normal hearing i.e. able to hear forced whisper from a distance of 6 meters by each ear separately.

9.5. Dental.

Should have healthy gums, good set of teeth and minimum 14 dental points. Dental implants and Implant Supported Prosthesis will not be awarded any dental points. Candidates wearing fixed or removable orthodontic appliances will be declared unfit.

9.6. General Health.

Candidate should be fit for the Air Force, must conform to the medical standards and should be of normal anatomy without loss or deformity of any appendages. He / She should be free from any active or latent, acute or chronic, medical or surgical disability or communicable disease, infection and skin ailments. Candidate shall be physically and mentally FIT to perform duty in any part of the world, in any climate and terrain.

9.7. Gynecological Examination (For female candidates).

The examination covers external genitalia, hymen orifices and the perineum, any evidence of stress urinary incontinence or genital prolapse outside menses.

9.8. Gender.

Any candidate if found to have predominant characteristics of the opposite gender as evident on external physical examination, will be rejected as Unfit. Any candidate having undergone gender reassignment surgery will be declared Unfit.

9.9. Pregnancy (For female candidates).

Any candidate, if found pregnant shall be disqualified and her candidature will be

9.10. Visual standards.

Note:-

9.10.1. Candidates should bring latest prescription (not older than one month) and spectacles for corrected vision, if used. The prescription must bear the diopter measurement, name, signature, stamp and registration number of Ophthalmologist. Date of prescription should be within a month prior to appearing for medical examination.

9.10.2. Candidates with history of LASIK/ PRK will not be accepted.

9.11. Details of medical standards are available on CASB web portal <https://ibscruitment.ecdfc.in>

9.12. Above mentioned medical standards are broad guidelines. Medical fitness will be conclusively decided by Medical Board.

10. **Consumption of Narcotic Drugs and Psychotropic Substance (NDPS).** Consumption of Narcotic Drugs and Psychotropic substances banned under the NDPS Act 1985 shall be a reject criterion for selection into the IAF. Agniveervayu found either in possession or storing or distributing or consuming such drugs and substances after enrolment shall be liable for disciplinary action including dismissal from the IAF. ZERO TOLERANCE POLICY TO ALCOHOLISM AND SUBSTANCE ABUSE IS FOLLOWED IN IAF.

11. **Body Tattoo.** Permanent body tattoos are not permitted. However, tattoos only on inner face of the fore arm (inside of elbow to the wrist), back (dorsal) part of the hand/ reverse side of palm and Nails with tattoos which are as per custom and traditions of their tribes may be considered. Offensive, obscene, indecent, sexist or racist tattoos are prohibited regardless of location on the Body. However, right to consider a tattoo acceptable or unacceptable will rest with the Selection Center. Candidates with permanent body tattoos are to submit two postcard size photographs (close up and distant view) with details of size and type of the Tattoo.

12. **Only Sikh candidates,** whose religion prohibits cutting of hair or shaving of face, shall be permitted to grow hair and/ or retain beard and moustache. Accordingly, those Sikh candidates willing to retain the same as per laid down specification are to get their photographs with beard and moustache.

TERMS AND CONDITIONS

13. Agniveervayu will be enrolled in the Indian Air Force under Air Force Act 1950, for a period of FOUR years. Agniveervayu would form a distinct rank in the Indian Air Force, different from any other existing ranks. The Indian Air Force is not obliged to retain Agniveervayu beyond the engagement period of four years.

14. On completion of four years of service, based on organization's requirements and policies promulgated by the Indian Air Force, Agniveervayu will be offered an opportunity to apply for enrolment in the regular cadre of the Indian Air Force as Airmen. These applications will be considered in a centralized manner based on objective criteria, including performance during their four-year engagement period and up to 25% of each specific batch of Agniveervayu will be enrolled in regular cadre of Indian Air Force. Agniveervayu will not have any right to be selected for the Government of India. Selection of the Agniveervayu for further enrolment, if any, shall be at the discretion of the Government of India.

15. **Employability.** Agniveervayu enrolled under the entry are liable to be assigned any duty in organisational interest at the discretion of the Indian Air Force.

16. **Training.** On being enrolled, Agniveervayu will be imparted military training based on Indian Air Force requirements.

17. **Leave.** Grant of leave will be subject to exigencies of the Indian Air Force. The following leave is applicable for Agniveervayu during their engagement period -

17.1. **Annual Leave.** 30 days per year.

17.2. **Sick Leave.** Based on medical advice by competent Medical Authority.

18. **Medical and CSD Facilities.** For the duration of their engagement period in the Indian Air Force, Agniveervayu will be entitled for medical facility at Service Hospitals as well as CSD provisions.

19. **Pay, Allowances and Allied Benefits.** Agniveervayu enrolled under this Scheme will be paid an Agniveer package of ₹30,000/- per month with a fixed yearly increment. In addition, Risk and Hazard allowances (as applicable in Indian Air Force), Dress and Travel allowances will be paid. Perks such as ration, clothing, accommodation and Leave Travel Concession (LTC) shall also be provided as per the existing rules.

20. **Terminal Benefits - Seva Nidhi Package.** Agniveervayu will be given one time 'Seva Nidhi' package comprising of their monthly contribution along with matching contribution by the Government on completion of their engagement period, as indicated below -

Note 1:- Agniveeray will not be required to contribute to any Provident Fund in Indian Air Force

Note 2:- There shall be no entitlement to gratuity and any kind of pensionary benefits.

21. **Insurance, Death and Disability Compensation.** Agniveeray will be provided non-contributory Life Insurance cover of ₹ 48 Lakhs for the duration of their engagement period as Agniveeray in the Indian Air Force. Agniveeray will not be governed by provisions contained in the Pension Regulations/ Rules for Indian Air Force. For details of Death/ Disability compensation log on to <https://afrecruitment.edcll.co.in>.
22. **Agniveer Skill Certificate.** At the end of engagement period, a detailed Skill-Set certificate will be provided to the Agniveeray, highlighting the skills and level of competency acquired by the personnel during their engagement period.
23. **Not Entitled to the ESM Status.** Agniveeray enrolled under this Scheme will not be eligible for Ex-Servicemen status after their discharge from the Service on completion of four years engagement period.
24. Agniveeray will be permitted to appear for NDA/ AFCAT examinations (maximum three attempts) during their engagement period of four years provided they satisfy certain conditions for obtaining permission to do so. Agniveeray, who have applied for any such examination prior to their enrolment in IAF may be permitted to appear in the same.
25. Release at own request prior to completion of engagement period will not be permissible for Agniveeray. However, in exceptional cases, personnel enrolled as Agniveeray may be released, with approval of the Competent Authority.

SEQUENCE OF EXAMINATION

MOBILE PHONES / SMART WATCHES / ELECTRONIC DEVICES ARE PROHIBITED IN TESTING AREAS DURING PHASE-I AND PHASE-II. CANDIDATES FOUND IN POSSESSION OF MOBILE PHONES/ ELECTRONIC DEVICES SHALL BE DEBARRED PERMANENTLY

Phase-I

28. **Online Test.** Eligible candidates will be sent admit cards for Phase - I of testing on their registered e-mail ID between 48-72 Hr prior to the examination. Candidates are required to download the admit card, take a colour printout and carry the same to the examination centre. Name of city & exam date will be intimated to the candidates at an earlier date to enable them to plan their movement. This provisional admit card can also be downloaded by the candidate under candidates login on CASB web portal <https://afrecruitment.edcll.co.in>. All candidates in possession of provisional admit card will undertake Online Test at centres designated / allotted as per their admit card. Online test will be objective type and questions will be bilingual (English & Hindi) except for English paper. Candidates are to bring one blue/ black pen and original AADHAAR card along with them for Phase - I testing. Details of the test are as follows:-

26.1. **Science Subjects.** Total duration of the online test shall be 60 minutes and shall comprise of Physics, Mathematics and English as per 10+2 CBSE syllabus.

26.2. **Other than Science Subjects.** Total duration of the online test shall be 45 minutes and shall comprise of English as per 10+2 CBSE syllabus and Reasoning & General Awareness (RGA).

26.3. **Science Subjects & Other than Science Subjects.** Total duration of the online test shall be 85 minutes and shall comprise of Physics, Mathematics and English as per 10+2 CBSE syllabus and Reasoning & General Awareness (RGA).

26.4. **Marking pattern for online test :-**

26.4.1. One mark for every correct answer.

26.4.2. Nil (0) marks for unattempted question.

26.4.3. 0.25 marks shall be deducted for each wrong answer.

Note:- Above examination methodology has been designed to facilitate selection process based on qualifications of candidates. Irrespective of the examination methodology Agniveeray enrolled under this entry are liable to be assigned any duty in organisational interest, at the discretion of the Indian Air Force.

27. Marks scored by the candidates in STAR Phase-I Testing will be "Normalised" by using the formula as published on the web site <https://afrecruitment.edcll.co.in>, to take into account variation in difficulty levels of the question papers across different sessions. Candidates are to note that the application of Cut-Off for shortlisting of candidates for STAR Phase-II testing and preparation of Final Merit List for selection will be based on "Normalised Marks" and not on the "Actual Marks" scored by the candidate in STAR Phase-I testing. Further, on normalisation, marks scored by a candidate in a subject may become less/ more than actual marks, and more than total marks of that subject in exceptional cases. Shortlisting for Phase-II testing will be carried out in state-wise manner. The Cut-Off marks for shortlisting for Phase-II testing may vary from state to state as vacancies have been allocated in a state-wise manner.

28. **CANDIDATES ARE TO QUALIFY IN EACH PAPER INDIVIDUALLY IN SCIENCE SUBJECTS AND OTHER THAN SCIENCE SUBJECTS,** with normalised marks. The result of Phase-I and state-wise shortlisting for Phase-II, based on their performance in Phase-I online test, will be updated in candidate's individual log in ID on <https://afrecruitment.edcll.co.in>.

29. In the event of extraneous circumstances resulting in non-conduct of STAR online test for Intake 01/2027, Indian Air Force reserves the right to age limit as on date of enrolment.

30. **Instructions for Examination.** Question paper will be made available to candidates during the online examination. In addition to this, Question Paper with Answer Key and Individual Response will be made available for three days in candidates' webpage login during the period of 'Objection Management' shortly after examination. No queries pertaining to Question Paper with Answer Key and Response Sheet of the candidate will be entertained through any means after lapse of the 'objection management' period. No RTI will be entertained for the information already made available through official website/ candidates' webpage login. No query pertaining to STAR will be entertained after six months from the date of exam. Candidates will not be permitted to leave the exam hall till completion of the examination.

Phase - II

31. Soon after the declaration of the result of Phase-I (Online) Test, a cut off will be applied on the normalised marks scored by the candidates in the Phase-I Test and state-wise SHORTLISTED candidates will be sent a new Admit Card on their registered e-mail IDs for Phase-II test at a designated ASC. This Admit Card for Phase-II exam can also be downloaded online under candidate's login on CASB web portal <https://afrecruitment.edcll.co.in>. Candidates have to report on the stipulated date and time for Phase-II at the designated ASC along with following:-

31.1. Colour print out of Phase-II Admit Card.

31.2. Colour print out of duly filled application form downloaded on completion of online registration.

31.3. HB pencil, eraser, sharpener, glue stick, stapler and black/blue ball point pen for writing.

31.4. Eight copies of un-attested passport size colour photograph (which was used for the online application registration).

31.5. Original or digilocker verified printout and four self-attested photocopies of matriculation passing certificate (required for verification of candidate's name, father's name and his/ her date of birth).

31.6. Original or digilocker verified printout and four self-attested photocopies of matriculation marks sheet (only applicable for three years Diploma/ two years Vocational Course holders when English is not a subject in Diploma/ Vocational Course).

31.7. Original or digilocker verified printout and four self-attested photocopies of Intermediate/ 10+2/ equivalent examination passing certificate and marks sheet.

OR

Original or digilocker verified printout and four self-attested photocopies of three years diploma course passing certificate and marks sheets of all semesters.

OR

Original or digilocker verified printout and four self-attested photocopies of two years Vocational Course passing certificate and all marks sheets including non-vocational course with subjects English, Physics and Mathematics.

31.8. Original and four self-attested photocopies of Domicile Certificate/ COAFP Certificate. The candidate shall produce the chosen 'Domicile Certificate' issued by any Gazetted Officer in Revenue Department or any other official authorized by the State Government of the particular state/ UT/ or COAFP Certificate while reporting for Phase-II examination.

31.9. Original and four self-attested photocopies of duly filled Children of Air Force Personnel (COAFP) Certificate (format available on CASB webpage) for Children of Serving Air Force Personnel (or Original and four self-attested photocopies of Service Book/ Discharge Book/Casualty Service Certificate/ Service Particular certificate (issued from DPO-3/DAV, as applicable) in case of Officer/ Airmen/ NCOs(E) and a certificate duly signed by OIC Civil Admin and countersigned by COIC Adm O of the last served unit, in case of civilians for Children of retired/ deceased/ discharged Air Force personnel and proof of minimum stay of one year.

31.10. Original Phase-I Admit Card used during Phase-I test bearing Air Force seal and invigilator's signature.

31.11. Body tattoo photographs as per Para 11 above.

31.12. Original and four self-attested photocopies of NCC 'A', 'B' or 'C' certificate (if applicable).

31.13. Copy of permission letter obtained from unit station (Applicable only for serving Agv NC).

Note-1:- Original NCC certificate must have serial No., round seal of issuing authority and stamp of signing authority. Photo affixed on the certificate must have been attested by issuing authority with stamp. Original digitally signed NCC certificates with QR code will also be accepted.

Note-2:- Candidates discharged from Indian Army/ Indian Navy/ any other Government Organisation shall also be eligible subject to their discharge with NO ADVERSE ENTRIES. Such candidate has to declare at the time of testing for Phase-II that he/ she is an Ex-employee of above

said organisations and produce original Discharge Certificate. In case of serving individuals, they must be in possession of NOC from their employer at the time of Phase-II. If any candidate does not disclose the fact of being employed or that of being an Ex-employee, his/ her candidature shall be cancelled at any stage during the selection process and if selected, shall be liable for discharge/ dismissal from the service for hiding the fact of his/ her employment. Candidates discharged from the Indian Air Force for any reason are not eligible to appear in the selection test. Candidates declared permanently unfit from any previous Air Force exam due to malpractices or any unfair activity are not eligible to appear in the selection test. If found at a later stage, the candidature will be cancelled automatically.

Note-3:- Candidates declaring wrong Domicile Certificate/ COAFP Certificate shall not be permitted to appear in the Phase-II stage of recruitment, training and thereafter.

32. **Verification of eligibility.** Candidates should be in possession of the documents mentioned at para 31 above. When appearing for the selection test which would be scrutinised/ verified prior to commencement of Phase-II to ascertain the eligibility prima-facie. Detailed verification of all the documents listed at para 31 above shall be carried out in respect of candidates who pass Physical Fitness Test. Candidates of those who do not meet the laid down educational criteria shall be cancelled during initial verification of original certificates & mark sheets and also during detailed verification at ASC.

Note - 1:- In the case of COAFP, the name of the candidate, parent's name and the date of birth of the candidate as mentioned in the discharge book/ service book/ service particular certificate/ casualty certificate (as applicable) must be the same as mentioned in the matriculation passing certificate of the candidate.

Note - 2:- Under no circumstances, the candidates shall be permitted to appear in Phase-II of the selection test without original educational mark sheets/ passing certificates & documents mentioned above in paragraph 31. However, candidates with photocopies of educational mark sheets/ passing certificates may be permitted to appear in the selection test only on production of a certificate from colleges/ school/ Principal certifying that educational certificates/ mark sheets are deposited with college/ school. 11. Candidates discharged from Indian Army/ Indian Navy/ any other Government Organisation shall also be eligible subject to their discharge with NO ADVERSE ENTRIES. Such candidate has to declare at the time of testing for Phase-II that he is an Ex-employee of above said organisations and produce original Discharge Certificate. In case of serving individuals, they must be in possession of NOC from their employer at the time of Phase-II. If any candidate does not disclose the fact of being employed or that of being an Ex-employee, his candidature shall be cancelled at any stage during the selection process and if selected, shall be liable for discharge/ dismissal from the service for hiding the fact of his employment. Candidates discharged from the Indian Air Force for any reason are not eligible to appear in the selection test. Candidates debarred permanently from any previous Air Force entry due to malpractice or any unfair activity are not eligible to appear in the selection test. If found at a later stage, the candidature will be cancelled automatically.

TERMS AND CONDITIONS

12. **Tenure & Training.** Enrolment shall be for an initial period of 20 years (subject to service conditions) which may be extended up to the age of 57 years (subject to service conditions). Initially, candidates shall be sent for a Joint Basic Phase Training (JBPT) at designated Basic Training Institute. On successful completion of JBPT, candidates will be sent for trade training of specific duration which shall include security training or any other training as per service requirements. Training is however liable to be terminated at any time if the trainee fails to achieve the required standards in academics, profession, physical fitness and discipline or is found to be medically unfit. **AFTER SUCCESSFUL COMPLETION OF ALL STAGES OF TRAINING, THE AIRMEN SHALL BE DEPLOYED ON JOBS AS PER IAF REQUIREMENTS. TRADE ALLOTTED SHALL NOT BE CHANGED ON CANDIDATE'S REQUEST ON ANY GROUNDS.**

Note-1:- Candidates will not be permitted to stay with their family during the training period.

Note-2:- Unsuccessful candidates will not be permitted to get married till successful completion of their ab-initio training.

13. **Employability.** Airmen enrolled under this entry are liable to be assigned any duty in organisational interest at the discretion of the Indian Air Force.

14. **Pay & Allowances.** During training, a stipend of ₹14,600/- per month shall be paid. On completion of training the starting gross emoluments of the minimum of scale of pay including Military Service Pay (MSP) is ₹26,000/- per month. In addition, dearness allowance (as applicable) which, in subsequent years, may rise as per the career progression of the individual.

15. Other allowances such as Transport Allowance, Composite Person Maintenance Allowance (CPMA), Leave Pay Allowance (LPA), Children Education Allowance, HRA etc. shall also be addressable to Airmen, as per relevant government instructions.

16. **Higher Education.** Airmen shall be permitted to pursue higher education qualification only after acquiring prescribed skill grade in their trade and (prescribed years of service as stated in HRP (Human Resource Policy)).

17. **Perks.** Perks such as ration, clothing, medical facilities, accommodation, CSD facilities, Leave (60 days annual and 30 days casual in a calendar year as a privilege, subject to service exigencies), Recreational facilities, transport for school going children and Leave Travel Concession (LTC) shall also be provided as per the existing rules. Group Insurance Cover of ₹52.5 Lakh at a premium of ₹2000/- per month for all Airmen and facility of Group Housing Schemes are also extended.

18. **Job Specification of Medical Assistant Trade.** As a Medical Assistant, you are to be trained in nursing and first-aid. You will also be involved in management of medical stores, dispensaries and ward supervision and other Air Force duties.

Note:- Airmen shall also have to undertake any other tasks as assigned by superior authorities.

SEQUENCE OF EXAMINATION

MOBILE PHONES/ SMART WATCHES/ ELECTRONIC DEVICES ARE PROHIBITED IN TESTING AREAS DURING PHASE-I AND PHASE-II. CANDIDATES FOUND IN POSSESSION OF MOBILE PHONES/ ELECTRONIC DEVICES SHALL BE DEBARRED PERMANENTLY.

Phase - I

19. **Online Test.** Eligible candidates will be sent admit cards for Phase - I of testing on their registered e-mail IDs between 48-72 Hr prior to the examination. Candidates are required to download the admit card, take a colour printout and carry the same to the examination centre. Name of city & exam date will be intimated to the candidates at an earlier date to enable them to plan their movement. The provisional admit card can also be downloaded by the candidate under candidates login on CASB web portal <https://iafrecruitment.edcl.co.in>. All candidates in possession of provisional admit card will undertake Online Test at centres designated/ allotted as per their admit card. Online test will be objective type and questions will be bilingual (English & Hindi) except for English paper. Candidates are to bring one blue/ black pen and original AADhaar card along with them for Phase - I testing. Details of the test are as follows:-

19.1. Duration of online test will be 45 minutes and shall comprise English as per 10+2 CBSE syllabus and Reasoning & General Awareness (RAGA).

19.2. **Marking Pattern for Online Test (Objective).**

19.2.1 One mark for every correct answer.

19.2.2 Nil (0) mark for un-attempted question.

19.2.3 0.25 marks shall be deducted for each wrong answer.

Note:- Above examination methodology has been designed to facilitate selection process based on qualifications of candidates irrespective of the examination methodology Airmen enrolled under this entry are liable to be assigned any duty in organisational interest at the discretion of the Indian Air Force.

20. If required, marks scored by the candidates in STAR Phase-I testing will be 'Normalised' using the formula as published on the website <https://iafrecruitment.edcl.co.in>, to take into account variation in difficulty levels of the question papers across different seasons. Candidates are to note that the application of Cut-Off for shortlisting of candidates for STAR Phase-II testing and preparation of Final Merit List for selection will be based on 'Normalised Marks' and not on the 'Actual Marks' scored by the candidate in STAR Phase-I testing if normalisation is exceptional cases, it may be more than the total marks of that subject.

21. **CANDIDATES ARE TO QUALIFY IN EACH PAPER SEPARATELY, with normalised marks if normalisation is applied.** The result of Phase-I and shortlisting for Phase-II, based on their performance in Phase-I online test, will be uploaded in candidate's individual log in ID on <https://iafrecruitment.edcl.co.in>.

22. **Instructions for Examination.** Question paper will be made available to candidates during the online examination. In addition to this, Question Paper with Answer Key and Individual Responses will be made available for three days in candidates' webpages during the period of examination. **Objection Management** shortly after examination. No queries pertaining to Question Paper with Answer Key and Response Sheet of the candidate will be entertained through any means after close of the objection management period. No RTI will be entertained for the information already made available through official website/ candidates' webpage login. No query pertaining to STAR will be entertained after six months from the date of exam. Candidates will not be permitted to leave the exam hall till completion of the examination.

Phase - II

23. Soon after the declaration of the result of Phase-I (Online) Test, a cut off will be applied on the normalised marks scored by the candidates in the Phase-I Test if normalisation is applied and SHORTLISTED candidates will be sent a new Admit Card on their registered e-mail IDs for Phase-II test at a designated ASC. This Admit Card for Phase-II exam can also be downloaded online under candidate's login on CASB web portal <https://iafrecruitment.edcl.co.in>. Candidates have to report on the stipulated date and time for Phase-II at the designated ASC alongwith following:-

23.1. Colour print out of Phase-I Admit Card.

23.2. Colour print out of duly filled application form downloaded on completion of online registration.

23.3. HB pencil, eraser, sharpener, glue stick, stapler and black/ blue ball point pen for writing.

23.4. Eight copies of un-attached passport size color photograph (which was used for the online application registration)

23.9. Original Phase-I Admit Card used during Phase-I test bearing Air Force seal and invigilator's signature.

23.10. Body photo photographs as per Para 9 above.

23.11. Original and four self-attested photocopies of NCC 'A', 'B' or 'C' certificate (if applicable).

23.12. NCC in original and four self-attested photocopies from the employer for candidates presently serving in any government organisation (if applicable).

23.13. For candidates discharged from Indian Army/ Indian Navy/ Any other Government Organisation, Original and four self-attested photocopies of Discharge Certificate (as issued from Indian Army/ Indian Navy/ Government Organisation).

Note: Original NCC certificate must have serial No., round seal of issuing authority and stamp of signing authority. Photo affixed on the certificate must have been attested by issuing authority with stamp. Original digitally signed NCC certificates with QR code will also be accepted.

24. **Verification of Eligibility.** Candidates should be in possession of the documents mentioned at para 23 above, when appearing for the selection test which would be scrutinised/verified prior to commencement of Phase-II to ascertain the eligibility prima-facie. Detailed verification of the documents listed at para 23 above shall be carried out in respect of candidates who pass Physical Fitness Test. Candidates of those who do not meet the last down educational criteria shall be cancelled during initial verification of original certificates & mark sheets and also during detailed verification at ASC.

Note-1- In the case of SOAPP, the name of the candidate, parent's name and the date of birth of the candidate as mentioned in the discharge book/ service book/ service particular certificate / casualty certificate (as applicable) must be the same as mentioned in the matriculation passing certificate of the candidate.

Note-2- Under no circumstances, the candidates shall be permitted to appear in Phase-II of the selection test without original educational marks sheets/ passing certificates & documents mentioned above in paragraph 23. However, candidates with photocopies of educational marks sheets/ passing certificates may be permitted to appear in the selection test only on production of a certificate from college/ school/ Principal certifying that the printout of digilocker verified certificates and must carry the accessible mobile devices to show the same certificates in digilocker during verification by selection team.

25. **Physical Fitness Test (PFT).** Names of the shortlisted candidates, who qualify the online test, shall be displayed on the CASB Web Portal <https://infrecruitment.edcl.co.in> and on a stipulated date shall be called at designated ASC for Physical Fitness Test (PFT) and Adaptability Test I & II. PFT consist of two parts i.e. PFT-I & PFT-II.

PFT-I. Candidates have to complete 1.6 Kms run as per the following timing to qualify PFT-I-

PFT-II. Candidates who qualify PFT-I to undergo PFT-II after 10 minutes of recuperation time. The sequence of exercises and maximum time period are as follows:-

Note: Candidates are advised to bring their sports shoes and shorts/ track pants. Detailed procedure on expected technique for Push-ups, Sit-ups and Squats is available on CASB Web Portal <https://infrecruitment.edcl.co.in>.

26. Candidates shall sign a consent form prior to appearing in physical fitness test/ medical test for selection in IAF. He shall appear in these tests at his own risk and shall not be paid any compensation by IAF for injury/ casualty if any, sustained by him during such tests. The consent form shall be signed by his parent/ guardian of candidates below 18 years of age. The consent form would be appended with Phase-I admit card.

27. **Adaptability Test-I.** All candidates who pass the Physical Fitness Test (PFT) shall have to undertake Adaptability Test-I (objective type written test) which is to assess suitability of a candidate for employment in the IAF which involves deployment in varied geographic terrain, weather and operational conditions.

28. **Adaptability Test-II.** All candidates who pass Adaptability Test-I will have to undertake Adaptability Test-II as per policy in vogue. Adaptability Test-II is to select candidates who can adapt to the environment of the Indian Air Force and are able to adjust to the military way of life.

Phase - III

29. **Medical Examination.** Candidates who qualify Adaptability Test-II shall be issued with medical appointment letter by respective ASCs. Medical examination shall be conducted by Air Force Medical Team as per Indian Air Force medical standards in IAF Publication and policy in vogue on subject issue. Medical examination would also include Baseline Investigations of:-

- 29.1. Blood Haemogram - Hb, TLC, DLC & Platelets.
- 29.2. Urine REME.
- 29.3. Biochemistry.
 - 29.3.1. Blood Sugar Fasting & Post Prandial.
 - 29.3.2. Serum Cholesterol.
 - 29.3.3. RFT - Serum Urea, Uric acid & Creatinins.
 - 29.3.4. LFT - Serum Bilirubin, SGOT, SGPT.
- 29.4. Radiograph chest (PA view)
- 29.5. ECG (R).
- 29.6. Any other investigation deemed necessary by the Recruiting Medical Officer.

30. Candidates declared medically unfit can avail the option for 'Appeal Medical Board' (AMB) against their unfitness by depositing ₹ 40/- in a Government Treasury/ RBI SBI through Electronic Money Receivable Order (e-MRO)/ Military Receivable Order (MRO). The application for AMB along with an original copy of e-MRO/ MRO, photocopy of Unfitness Certificate are to be submitted to the representative of ASC within three working days of medical examination.

31. The Recruitment Medical Officer and the specialist doctors of Armed Forces are the final authorities on declaring a candidate Fit or Unfit during Initial Medical Examination, Appeal Medical Board and Medical Examination prior to Enrolment.

32. The candidates shall be governed by Armed Forces Medical standards which may be at variance from civil standards. There is no provision for representation or review after the Appeal Medical Board.

Note-1- Candidates are advised to get tartar and stains removed from their teeth before appearing for the medical examination. Ears should be free of wax. Candidates should be prepared to stay for the medical examination for four to five days under their own arrangement. No TA/ DA shall be admissible.

Note-2- Passing in the medical examination is not a guarantee for employment in Indian Air Force.

Note-3 Request for change of Medical Examination Centre or Date of Medical Examination shall not be entertained.

INSTRUCTIONS FOR SUBMISSION OF ON-LINE APPLICATION

33. How to apply.

33.1. Candidates are to fill ONLINE Applications by logging on to <https://infrecruitment.edcl.co.in>. Candidate must have his valid e-mail ID and Mobile No. for successful online registration. The e-mail ID and mobile No. entered by the candidate in his online application form must remain valid throughout the recruitment process. Application Sequence Number, password and all other important communication will be sent on the same registered e-mail ID & Mobile No. (Please ensure that email sent to the mailbox of registered e-mail ID is not redirected to junk/ spam folder).

33.2. Candidates should take utmost care in furnishing/ providing the correct details while filling up the on-line application.
