ORDER (U/S 133 Cr.PC.)

Whereas, the National Commission for Protection of Child Rights (NCPCR) in collaboration with Narcotics Control Bureau (NCB) has prepared and released a Joint Action Plan on "Prevention of Drugs and Substance Abuse among Children and Illicit Trafficking".

Whereas, it is imperative to issue necessary direction to the Medical stores of Udalguri District selling schedule "H", "H1" and "X" Drugs for monitoring their sale.

Therefore, I, Dr. Sadnek Singh, IAS, District Magistrate, Udalguri in exercise of powers conferred upon me under section 133 of Cr.P.C. do hereby direct the following for strict compliance.

- 1. All the Medical / Pharmacy shops of Udalguri District selling schedule "H", "H1" and "X" Drugs as per Rules 65 (3) of the Drugs and Cosmetics Act, 1940 are hereby directed to install CCTV cameras inside and outside their shops.
- 2. Time period of 30 days is being given to all the Medical / Pharmacy shop owners for installation of CCTV cameras. Footage of such cameras can be randomly checked by the District Drug Controller Authority / Child Welfare Police Officer (CWPO) at any time.
- 3. In case any Medical shop owner fails to comply with these directions, appropriate action shall be taken against him/her.

Concerned Circle Officer and Executive Magistrate shall execute this order within their respective jurisdiction with the help of Police & Drugs Inspector and submit reports accordingly. Given under my hand & seal on this day of 8th August, 2023.
